### MONMOUTH COUNTRY CLUB MEMBERSHIP INFORMATION AND REQUIREMENTS

1. Each prospective member must submit a signed application to the Board of Directors for approval
2. Dues are charged to members on an annual calendar year basis and are payable by March 1st unless automatic monthly bill pay is prearranged by the member. Interest, as set forth by the Board, will accrue beginning April 1st on a monthly basis. Outstanding accounts will be denied club privileges. Each membership is entitled to one vote at the annual meeting or any called meetings of the membership.
3. Members may choose their membership category. The unmarried children of FAMILY or SINGLE members, who have not reached the age of 24 and who live with the member (including children attending college, university or other trade/technical school or adult children living at home with special needs) shall enjoy the same privileges of the club as their parents' class of membership however nonresident children of members will not benefit from club membership and may obtain their own desired level of membership.

### RESIGNATIONS:

1. The resignation of a member must be made in writing to the Club Secretary.
2. The resignation of a member prior to the end of the calendar year, DOES NOT relieve the member of the obligation to pay the remainder of annual dues.
